

Imdex Limited (ACN 008 947 813) and its Related Bodies Corporate (as defined by the provisions of the *Corporations Act 2001* (Cth)) (**Imdex**) is committed to protecting the privacy of individuals and their personal information in accordance with the *Privacy Act 1988* (Cth) (**Privacy Act**), including the Australian Privacy Principles (**APPs**), Part IIIA of the Privacy Act and the Privacy (Credit Reporting) Code (**CR Code**).

The Privacy Act and the CR Code contain provisions regarding the use and disclosure of credit information, which applies in relation to the provision of both consumer credit and commercial credit (as defined by the Privacy Act).

This Credit Reporting Policy:

- sets out how Imdex collects, uses, discloses and otherwise manages credit-related information; and
- forms part of, should be read in conjunction with, Imdex's Privacy Policy which can be found here or at: <https://www.imdexlimited.com/page/privacy-policy>

1. What is Credit Information?

- 1.1. Credit information is information that is taken into consideration when you apply for or use credit that has been provided to you, whether in relation to trade credit offered by Imdex or by any third party such as a credit provider. Credit information also includes information derived from receiving credit reports about you (defined as "*CP derived information*" under the Privacy Act) and credit eligibility information (as defined under the Privacy Act).
- 1.2. As Imdex provides terms of payment of accounts which are greater than 7 days, we are considered a credit provider under the Privacy Act in relation to any credit we may provide you (in relation to the payment of your account with us). In addition, and without limitation, when you apply for trade account, we may need to carry out credit reference checks in relation to you. One of the checks undertaken will include, but will not be limited to, obtaining a credit report about you.
- 1.3. To the extent necessary, you give your **express consent** in order for Imdex to obtain one or more credit reports about you, from one or more credit reporting bodies.

2. What kinds of Credit Information do we collect and hold about you?

- 2.1. In general we will require information from you in relation to your identification, such as your name, address, date of birth, contact numbers, email address, and your driver's licence or passport details.
- 2.2. We may also collect the following types of information, without limitation:
 - a. that you have applied for credit or trading account, the type and amount of that credit;
 - b. the details of the credit that you have applied for (and, if applicable, that is provided to you), including the dates of any credit contract entered into, the termination date, your repayment history and any related information, your default information;

- c. any information pertaining to your credit worthiness and credit history which is contained within a credit report;
 - d. an opinion we have on reasonable grounds that you have committed a serious credit infringement in relation to any credit that has been provided to you;
 - e. details pertaining to your financial position, including any bank account details;
 - f. other credit information related to your credit worthiness which is derived by us or any credit reporting body; and
 - g. any other credit information considered relevant by Imdex.
- 2.3. As much as possible or unless otherwise provided under this Credit Reporting Policy, we will collect your information directly from you. If we collect details about you from someone else, we will, whenever reasonably possible, make you aware that we have done this and why, unless such information:
- a. is received from any trade referee or accountant you have listed on any application form with Imdex;
 - b. is collected from publicly available sources, including but not limited to any court proceeding information, personal insolvency information and credit related publicly available information; or
 - c. is collected as otherwise required or authorised by law.
- 2.4. To the extent necessary, you expressly consent to Imdex obtaining credit information about you from the types of organisations and individuals listed in paragraph 2.3.

3. Purpose for collecting and using your Credit Information

- 3.1. We will only use or disclose your credit information for the primary purposes for which it was collected or as consented to or as otherwise set out below.
- 3.2. You consent to us using and disclosing your credit information collected in accordance with paragraph 2, to facilitate a purpose in connection with:
- a. if required, the verification of your identity and date of birth;
 - b. the provision of Imdex's products and services to you, which includes but is not limited to:
 - i. contacting you to discuss your enquiry regarding products and services Imdex can provide to you;
 - ii. the administration and management of our products and services, including charging, billing, credit card authorisation and verification, checks for financial standing, credit-worthiness (including but not limited to undertaking an assessment for credit loss and obtaining credit references, if applicable), fraud and collecting debts;

- iii. collecting any amounts you may owe us in relation to any credit and dealing with serious credit infringements;
 - iv. assisting you to avoid defaults;
 - v. any complaints or disputes in relation to any credit facility offered to you; and
 - vi. using the information for our own internal assessment of your credit worthiness (as undertaken by Imdex);
- c. the administration and management of Imdex, which shall include, but is not limited to:
- i. any auditing or governance requirements of Imdex;
 - ii. managing the credit that we may provide you; and
 - iii. managing our risks and to help identify and investigate illegal activity, such as fraud;
- d. to provide customer service functions, including handling customer enquiries and complaints (which shall include, but is not limited to, any complaints in relation to non-payment of any account with Imdex);
- e. to offer you updates, information or other content on products and services that may be of interest to you;
- f. our compliance with applicable laws; and
- g. any other matters reasonably necessary to continue to provide our products and services to you.

4. Disclosure of Credit Information

- 4.1. To the extent necessary, you expressly consent to Imdex disclosing your credit information, including any information derived from your credit information, to the following types of organisations outside of Imdex. Examples of organisations and/or parties that your credit information may be provided to include:
- a. offshore and Australian service providers, including IT service providers;
 - b. related entities and subsidiaries of Imdex;
 - c. third parties, such as the Australian Taxation Office, external debt recovery agents or the appropriate court (depending on the value of the debt) or other entities to whom we are required by law to disclose personal information;
 - d. applicable third parties, where we believe on reasonable grounds that you have committed a serious credit infringement;
 - e. any trade referees or accountants listed on your application form;
 - f. if applicable, credit references and trade references that have been nominated by you on any application form;
 - g. if applicable, credit reporting bodies, such as The Reporting Body (see paragraph 6 for further information);

- h. your financial institution and in some circumstances, our financial institution or other institution through which payment is made to us; and
 - i. our contractors and agents, including but not limited to Imdex's third party providers who undertake our bill and/or credit services on our behalf and any companies who assist us in providing our products and services to you, including but not limited to our auditors.
- 4.2. Your personal information and credit information is disclosed to these organisations and/or parties only in relation to the products or services we provide to you, for a purpose permitted by this Credit Privacy Policy and Imdex's Privacy Policy or as otherwise informed in a collection notification statement.
- 4.3. We may also use or disclose your personal information and in doing so we are not required to seek your additional consent:
- a. when it is disclosed or used for a purpose related to the primary purposes of collection detailed above and you would reasonably expect your personal information to be used or disclosed for such a purpose;
 - b. if we reasonably believe that the use or disclosure is necessary to lessen or prevent a serious or imminent threat to an individual's life, health or safety or to lessen or prevent a threat to public health or safety;
 - c. if we have reason to suspect that unlawful activity has been, or is being, engaged in; or
 - d. if it is required or authorised by law.
- 4.4. In the event we propose to use or disclose such personal information other than for reasons set out in this Credit Reporting Policy or as otherwise provided by Imdex's Privacy Policy, we will first seek your consent prior to such disclosure or use, unless such use or disclosure is otherwise required by law.

5. How do we store Credit Information?

- 5.1. We will store any credit information you provide to us, or which we obtain about you, with any other personal information we may hold about you, which shall include but is not limited to the use of paper files, electronic files and databases.
- 5.2. As indicated in our Privacy Policy, we do utilise third party service providers who either assist us in the storage of your personal information or undertake services on our behalf which may require them to hold your personal information.

6. Credit Reporting Bodies

- 6.1. Imdex obtains credit reports from a number of agencies globally. These agencies include, but are not limited to:
- a. Equifax
 - b. Creditreform
 - c. NCI Risk Management
 - d. Sentinel

- e. CreditSafe
- 6.2. Imdex does not provide any credit information to credit reporting bodies, except in exceptional circumstances.
- 6.3. Each credit reporting body is required to have a credit reporting policy which explains how they will manage your credit-related personal information. To view the policy of any of these credit reporting bodies please visit the relevant credit reporting body's website (as indicated in the nominated credit provider's credit reporting policy) and follow the relevant "Privacy" links, or you can contact them directly for further information.
- 6.4. You have the right to request that the credit reporting body not use or disclose credit reporting information it holds about you in circumstances where you reasonably believe that you have been or are likely to be a victim of fraud, including identity-related fraud. You must contact the credit reporting body directly should this be the case.

7. Overseas Disclosure

- 7.1. Except as provided by paragraph 7.2, Imdex does not generally disclose credit information overseas, unless you are conducting business overseas or unless one of the types of organisations listed in paragraph 4.1 is based overseas.
- 7.2. As indicated in our Privacy Policy, we do utilise overseas service providers in relation to personal information (excluding credit information). Please see our Privacy Policy for further details.

8. Access To and Correction of Your Credit Information

- 8.1. You are entitled to have access to your credit information relating to you which we possess, except in some exceptional circumstances provided by law. You are also entitled to edit and correct such information if the information is inaccurate, out of date, incomplete, irrelevant or misleading.
- 8.2. If you would like access to or correct any records of personal information or credit information that we have about you, you are able to access and update that information by contacting us via the details set out at in the next section.
- 8.3. We will need to verify your identity before giving you access to your credit information. We will respond to a request for access within a reasonable period. In relation to credit eligibility information, we will usually provide the information requested within a period of 30 days unless unusual circumstances apply. If we are unable to agree to your request for access, we will advise you of this in writing.

8.4. Resolving Privacy Complaints

- 8.5. We have put in place an effective mechanism and procedure to resolve privacy complaints. We will ensure that all complaints are dealt with in a reasonably appropriate timeframe so that any decision (if any decision is required to be made) is made expeditiously and in a manner that does not compromise the integrity or quality of any such decision.

8.8. In order to resolve a complaint, we:

- a. will liaise with you to identify and define the nature and cause of the complaint;
- b. may request that you provide the details of the complaint in writing;
- c. will keep you informed of the likely time within which we will respond to your complaint;
and
- d. will inform you of the legislative basis (if any) of our decision in resolving such complaint.

8.9. We will keep a record of the complaint and any action taken in a Register of Complaints.
